TCC may collect information about you from other individuals or organisations involved in the complaint for the above purposes.

If necessary to the investigation of the complaint, TCC may disclose the information you give us to the individuals or organisations named in the privacy complaint and to others who have information relevant to your complaint. In case of a challenge to TCC's conduct connected with your privacy complaint, the firm may need to disclose some of your personal information to a review body, for example, the Commission d'accès à l'information, or other court or tribunal. TCC is not likely to disclose your personal information to any overseas recipients unless your complaint relates to an overseas contracted service provider of TCC.

You are not required to provide TCC with your contact details and may make a privacy complaint anonymously. However, if you do not provide your contact details, TCC may not be able to properly investigate your complaint or inform you of the action, if any, taken in response to your complaint.
